Performance of the Fund Since February 25, 2018



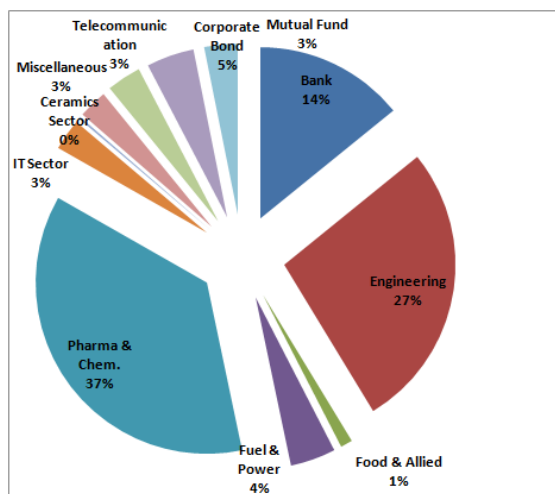
